OBJECTIVE

The objective of the Buy America Pre-Award Audit is to determine whether the <u>proposed</u> transit buses to be built by the Transit Vehicle Manufacturer comply with the applicable FTA Buy America Pre-Award Requirements for rolling stock procurements.

SCOPE

The scope of the Buy America Pre-Award Audit includes:

- □ A review of the Buy America Certificate of Compliance, as filed by the transit vehicle manufacturer, NEW FLYER of AMERICA, Inc., to determine compliance with 49 CFR 661.12.
- A review of the Domestic Content Compliance Worksheet the transit vehicle manufacturer's listing of transit vehicle components, subcomponents, country of origin and US manufacturing location including city and state, to verify that the transit vehicles contain more than 65% domestic content, and to determine compliance with 49 CFR 661.
- □ A review of the components listed on the Domestic Content Compliance Worksheet to determine compliance with 49 CFR 661.11 Appendix C.
- A review of the proposed final assembly location to determine that final assembly will take place in the USA.
- A review of the list of proposed final assembly activities to ensure that such activities qualify as final assembly activities as defined by the FTA.
- □ A review of the transit vehicle manufacturer's estimated cost of final assembly.
- An on-site visit to the transit vehicle manufacturer's US bus manufacturing facilities in Crookston, Minnesota to examine the records necessary to substantiate that the cost of components produced in the United States comprise more than 65% of the cost of all the components included in the transit vehicles to be purchased.
- An on-site visit to the transit vehicle manufacturer's assembly plant in Crookston, Minnesota to observe the proposed site of the final assembly location, the vehicle final assembly process, and final assembly activities, and to determine that final assembly will take place in the USA.

DELIVERABLE

The consultant will provide a Buy America Pre-Award Audit Report that will conclude with a statement of whether or not the subject vehicles to be purchased from New Flyer of America comply with Buy America Pre-Award requirements.

OBJECTIVE

The objective of the Buy America Post-Delivery Audit is to determine whether the <u>actual</u> transit buses as built by the Transit Vehicle Manufacturer comply with the applicable FTA Buy America Post-Delivery Requirements for rolling stock procurements.

SCOPE

The scope of the Buy America Post-Delivery Audit includes:

- A review of the Buy America Certificate of Compliance, as filed by the transit vehicle manufacturer, NEW FLYER of AMERICA, Inc., to determine compliance with 49 CFR 661.12.
- □ A review of the Domestic Content Compliance Worksheet the transit vehicle manufacturer's listing of transit vehicle components, subcomponents, country of origin, and US manufacturing location including city and state, to verify that the transit vehicles contain more than 65% domestic content, and to determine compliance with 49 CFR 661.
- □ A review of the components listed on the Domestic Content Compliance Worksheet to determine compliance with 49 CFR 661.11 Appendix C.
- A review of the actual final assembly location to determine that final assembly actually takes place in the USA.
- A review of the list of actual final assembly activities to ensure that such activities qualify as final assembly activities as defined by the FTA.
- □ A review of the transit vehicle manufacturer's reported cost of final assembly.
- An on-site visit to the transit vehicle manufacturer's US bus manufacturing facilities in Crookston, Minnesota to examine the records necessary to substantiate that the cost of components produced in the United States comprised more than 65% of the cost of all the components included in the transit vehicles purchased.
- An on-site visit to the transit vehicle manufacturer's assembly plant in Crookston, Minnesota to observe the actual site of the final assembly location, the transit vehicle final assembly process, final assembly activities, and to determine that final assembly takes place in the USA.
- A review and analysis of Buy America certificates obtained by NEW FLYER of AMERICA, Inc. from component suppliers to support representations made by the transit vehicle manufacturer regarding country of origin and domestic

Recipient's Buy America Certificates

The Recipient's Buy America certificates are excluded from this proposed scope of work. The City of Albuquerque, the FTA grant recipient (grantee), is required to complete, sign and retain three Buy America Post-Delivery certifications relevant to the purchase of the ten New Flyer 60ft buses:

- 1. Buy America Audit Certificate;
- 2. FMVSS Certificate; and
- **3.** Purchaser's Requirements Certificate. This requires the following key elements:
 - a. Comparison of the transit vehicle manufacturer's as-built specifications to the Transit Authority's specifications to ensure that the buses as built comply with Transit Authority's requirements; and
 - b. Documentation that demonstrates the Recipient completed visual inspections and road tests of each transit vehicle

TIMEFRAME for COMPLETION of BUY AMERICA PRE-AWARD AUDIT REPORT

The firm of STEVE POLICAR LLC is immediately available to conduct the Buy America Pre-Award Audit of the New Flyer Xcelsior XD60 bus to be built at the New Flyer Crookston facility. COST ESTIMATE for BUY AMERICA AUDITS

BUY AMERICA PRE-AWARD and POST-DELIVERY AUDITS

Fee for Audit Services \$22,750 Expenses (Estimated) \$4,300

Total Estimated Cost \$27,050

Fee for audit services is based on two separate on-site visits to the New Flyer of America final assembly plant located in Crookston, Minnesota, one visit for the Pre-Award audit and one for the Post-Delivery Audit. Fees are based on 100% of the site work/field work for each audit being completed at the Crookston location. If site work location is different, this cost estimate is subject to revision to accommodate any resulting increases in level of effort and/or travel and out-of-pocket expenses.

Expenses listed above are estimated for purposes of this proposal and allow for the cost of one site visit to Crookston, Minnesota for each audit. Expenses shall be billed and reimbursed based on actual expense. Expenses include all travel and out-of-pocket expenses incurred in connection with the performance of the scope of work, including but not limited to lodging, meals, airfares, taxi, tolls, and local transportation. Domestic air travel shall be on coach or economy class. Lodging and meals shall be based on federal GSA per diem rates; all other expenses shall be based on actual cost. International travel shall be based on US Department of State daily meal & lodging rates. Travel and out-of-pocket expenses are not included in the fee for services; and will be billed at cost without markup.

Additional Work Any additional work required by the client that is outside the scope of work outlined for one Buy America Pre-Award Audit and one Buy America Post-delivery Audit will be billed at \$175 per hour.
